



Hong Kong's last major opposition party moves towards disbandment

Hong Kong : Hong Kong's last remaining major opposition party took a key step towards disbanding itself on Sunday after a special meeting approved arrangements to



do so in the face of pressure from China, amid a national security crackdown.

Five senior members of the Democratic Party had earlier told Reuters that Chinese officials or middlemen had warned it in recent months to disband or face serious consequences, including possible arrests.

The party, founded three years before

Hong Kong's return to Chinese rule from Britain in 1997, has been the Asian financial hub's flagship opposition, uniting democratic forces to push Beijing on democratic reforms, and to uphold freedoms. Party head Lo Kin-hei told reporters that 90 per cent of 110 members had voted at Sunday's meeting for a three-person committee to start making arrangements for disbandment, including resolving legal and accounting matters.

"I hope Hong Kong's political parties ... will continue to work for the people," Lo said at the party's headquarters. "We have always hoped to serve the Hong Kong people, and to do things that are good for society." After the panel completed its work, a final vote on dissolution would be

held in coming months, Lo added. The finalisation of the move requires a majority vote of 75 per cent.

Lo did not give an exact date for completion of disbandment, but said it could be as late as next year, adding, "Until the final dissolution, the party will keep on with its usual work."

Mian Mir body opens US chapter

AMRITSAR : Harbhajan Singh Brar, international president of the Sain Mian Mir Foundation (SMMF), today opened the US chapter of the foundation to promote the teachings of the great Sufi saint who had laid the foundation stone of the Golden Temple.

Renowned social worker and business tycoon of America, Jess Dhillon, who originally hails from Kairon, a border town in Tarn Taran district, has been nominated president of the US chapter. Dhillon has been authorised to nominate the other office-bearers.

Talking to The Tribune here, Dhillon said the aim of the SMMF would be to promote universal brotherhood, as preached by Sain Mian Mir and other Sufi saints. It would also publish literature on Sufism in different languages, including Urdu, Punjabi, English, French and Hindi.

Sain Mian Mir was a renowned Sufi saint of Lahore. Dhillon said young scholars the world over would be encouraged to do research on his life. The great Sufi saint had a religious bent of mind. As a child, he attentively listened to religious sermons. The US chapter of the SMMF would also construct a Sain Mian Mir Bhawan in California which would be used as a guest house for the visiting Sufis, saints, writers and journalists. The chapter would help complete another bhawan in Lahore, named after Sain Mian Mir.



He said the SMMF would organise the first international conference on Sufism in California next year where the foundation would also launch its own website shortly.

The SMMF would enroll Muslims, Hindus, Sikhs and members of other communities as its office-bearers so that representation is given to all communities of the world.

Assisted living isn't just for people. Zoo in Spain helps elderly elephants age gracefully

Barcelona : At the Barcelona Zoo, a 40-year-old African elephant places her foot through the metal barrier where a zookeeper gently scrubs its sole — the beloved pachyderm gets her "pedicure", along with apple slices every day.

The treatment is part of the zoo's specialised geriatric care for aging animals that cannot be reintroduced into the wild as zoos world over increasingly emphasise lifelong care.

"Sending them back into nature would be an error," said Pilar Padilla, head of the zoo's mammal care. "It is very likely they wouldn't survive." Zoos have undergone a rethink in recent decades with the emphasis on the conservation of species and education, moving away from the past paradigm that often displayed exotic animals as a spectacle.

The new approach includes knowing how to adapt to the needs of aging animals, which has led zoos to create bigger, more nature-like enclosures, such as the Sahel-Savannah area at the zoo in the Spanish city of Barcelona.

Along with breeding programs to reintroduce fit animals into nature, zoos today want to ensure that animals living longer due to advancements in veterinary care can age gracefully, said Martín Zordan, the CEO of the World Association of Zoos and Aquariums, or WAZA.

"Specialised geriatric care is becoming increasingly essential," Zordan told The



Associated Press at the organisation's Barcelona offices.

Zordan said that just like older people, elderly animals require more care: regular health checks, arthritis treatment, softer foods or nutritional supplements, adapted living spaces and monitoring of mental and behavioral health.

Along with caring for a pair of aging elephants, the Barcelona Zoo is also the home for a 15-year-old wolf, a leopard and a tiger who are both 17, as well as some older birds — including a flock of senior flamencos.

It's not alone — several zoos in the United States, for example, highlight their treatment of older animals, such as the zoos

in Baltimore and Baton Rouge.

A study of grief

Zookeepers at the Barcelona Zoo, not far from the city's Mediterranean coastline, are closely monitoring its two aging female pachyderms, Susi and Bully (pronounced BUH-yi), as they cope with the recent death of Yoyo, their former pen-mate and long-time companion.

Yoyo died in December at age 54.

Susi, at 52, is now among the oldest known African elephants in captivity, even though WAZA said the age of animals born in the wild is approximate. Bully, who is 40, is also considered old for an African elephant. All three were captured in the wild and spent

time in circuses and other zoos before coming to Barcelona.

The zoo is now working with the University of Barcelona to study the impact of Yoyo's death on Susi and Bully. It's the first study of its kind, focused on elephants not from the same family after the death of a long-time companion, Padilla told The Associated Press during a recent visit to the zoo's elephant enclosure.

At first, Susi and Bully showed their shock by not eating, but are now adapting well and turning to one another, even sharing food, Padilla said, adding that Susi has taken on the dominant role that Yoyo had.

The proof is in the teeth

For elephants, their teeth are the real age test.

"What marks the decline of the animal is the wear on their teeth," Barcelona zookeeper José María Santamaría said after finishing the Bully's pedicure. "They go through six sets of molars during their life, and when they reach around 40 years old they lose the last set." Susi and Bully require daily checkups, food suited for their now molar-less mouths and extra attention to their legs — hence the daily pedicures and the enclosure's soft sandy floor to cushion aching feet.

"Those are the sort of considerations taken because we care about these animals living comfortably and leading lives with dignity," Zordan said.

A first, SC sets deadline for President to decide on Bills

New Delhi : In an unprecedented verdict, the Supreme Court has restricted the President's discretionary powers on Bills referred by Governors under Article 201 of the Constitution and set a three-month timeframe for her to decide on the Bills reserved for her consideration.

"The President is required to take a decision on the Bills reserved for his (her) consideration by the Governor within three months from the date when such reference is received. In case of any delay beyond this period, appropriate reasons would have to be recorded and conveyed to the state concerned," a Bench led by Justice JB Pardiwala said.

"Where the President exhibits inaction in making a decision on a Bill presented to him (her) for assent under Article 201 and such inaction exceeds the time-limit (of three months), then it shall be open to the state



government to seek a writ of mandamus from this court," said the Bench, which also included Justice R Mahadevan. In case of any delay beyond this period, appropriate reasons would have to be recorded and conveyed to the state concerned, the Bench said. "The states are also required to be collaborative

and extend cooperation by furnishing answers to the queries which may be raised and consider the suggestions made by the Central government expeditiously," it said. The top court said "that the simpliciter withholding of assent both by the President and the Governor would be impermissible within the

fundamental principles of a constitutional democracy".

Given its serious implications, the government was likely to request the top court to review the verdict, sources said.

Exercising its plenary power under Article 142 of the Constitution, the Bench declared that the 10 Bills would be deemed to have

received the Governor's assent when they were presented to him for the second time after having been passed by the state legislature again.

This is for the first time that such a timeframe has been set for the President. The verdict assumes significance in view of the fact that the Constitution

does not prescribe any such timeframe for the President for exercise of her executive powers on several issues, including mercy petitions and judicial appointments.

The Bench said the President should seek the Supreme Court's opinion under Article 143 of the Constitution on Bills referred to her consideration by the Governor under Article 201.

"Where a state Bill has been reserved by the Governor, in his discretion, for the consideration of the President on the ground that the Bill appears to be patently unconstitutional for placing the principles of representative democracy in peril, the withholding of assent by the President would, in ordinary circumstances, involve purely legal and constitutional questions and therefore be justiciable without any impediments imposed by the doctrine of political thicket," it said.

US trade uncertainties to undermine biz confidence, adversely impact growth in Asian region: Moody's

New Delhi : Uncertainties around the US trade policy will undermine business confidence and consumer sentiment, adversely impacting growth in Asian nations, including India, Moody's Ratings said on Sunday.

US President Donald Trump has postponed by three months the imposition of reciprocal tariffs, with the exception of China on whom a 125 per cent tariff has been slapped. However, a 10 per cent additional duty on exports to the US will continue.

"An escalation of US-Sino tensions and the spillover effects from a slowdown in China pose significant downside risks to the (Asian) region's growth prospects. Economies with large domestic markets, such as India, may benefit from companies seeking access to these markets but any major shift in investment flows would occur over several years," Moody's Ratings Senior Vice President, Credit Strategy & Guidance, Nicky Dang told PTI.

Last week, Moody's Analytics, another Moody's firm, had cut India's growth forecast for the 2025 calendar year to 6.1 per cent in 2025 from 6.4 per cent projected in February.

Dang said the tariff pause mitigates the negative impact of the additional tariffs on the region's trade and growth. However,



economies in the region still face considerable downside risk due to an additional 10 per cent universal tariffs and their high direct and indirect exposures to the US.

"The uncertainty surrounding US trade policies will likely continue to undermine business confidence and consumer

sentiment in the region, potentially lowering domestic demand and growth prospects. Furthermore, the additional tariffs on Chinese exports, which were not included in the pause, exert further pressure on China's growth," she said.

The tariff pause does not reverse the trend of de-globalisation but increases trade

policy uncertainty, as the Trump administration's goal of reshoring manufacturing supply chains to the US remains unchanged, Dang said.

Recent developments suggest changes in the global trade system, which had previously been trust and rule-based, have begun, and the broader impact on the global economy could be significant.

Exporters and trade experts in India have been saying that the 90-day period provides a crucial window for pushing the talks on the proposed bilateral trade agreement between India and the US.

The two countries are negotiating a bilateral trade agreement (BTA) with an aim to more than double their trade to USD 500 billion by 2030 from about USD 191 billion at present. They are aiming to conclude the first phase by the fall (September-October) this year.

"The 90-day moratorium provides some space for all governments to negotiate for more favourable terms... Higher overall tariffs still place some inflationary pressure on the US economy. In the meantime, policy uncertainties are likely to continue weakening business and consumer sentiment and reducing domestic demand, posing downside risks to growth," Dang added.

China privately admitted to US infrastructure cyberattacks: Report

Washington, DC : In a previously undisclosed meeting held last December, Chinese officials privately acknowledged responsibility for a series of cyberattacks on US infrastructure, according to individuals familiar with the discussions, as cited by The Wall Street Journal.

The meeting, which took place in Geneva, adds new depth to the growing tensions between Washington and Beijing.

According to The Wall Street Journal, the confidential summit was attended by representatives of the outgoing Biden administration. During the meeting, the Chinese delegation implied that the cyber intrusions - targeting US ports, water systems, airports, and other critical infrastructure, were connected to Washington's increasing support for Taiwan.

This marked a departure from China's usual stance of



denial, where such attacks were often attributed to criminal groups or dismissed as exaggerated claims.

The cyber campaign, identified by security researchers as Volt Typhoon, had already triggered significant concern among American officials last year. According to US intelligence, the effort was linked to China's military and aimed at embedding itself in American systems to enable swift, destructive attacks in the event of a future conflict, The Wall Street Journal

reported.

Though the Chinese officials' comments were vague, US representatives took them as a veiled admission of responsibility and a warning related to US-Taiwan relations, a former official said. Since the December meeting, ties between the two countries have continued to deteriorate, exacerbated by an ongoing trade war. In response, senior members of the Trump administration have vowed to initiate more aggressive cyber operations

targeting China, the report said.

Meanwhile, lawmakers and US officials told The Wall Street Journal that Beijing has continued to exploit American telecom systems through a separate cyber campaign known as Salt Typhoon, attributed to another Chinese hacking group.

Concerns have been further intensified by recent domestic changes. The administration has begun executing major job cuts affecting hundreds of cybersecurity roles. The dismissal of both the NSA director and deputy last week has raised serious concerns among intelligence experts and legislators, who worry these moves are weakening national cyber defences.

Officials now regard China's repeated targeting of civilian infrastructure as one of the most serious threats facing the Trump administration.

Plane with 2 people on board crashes in muddy field in upstate New York



Copake : A twin-engine plane with two people on board crashed Saturday in a muddy field in upstate New York, authorities said.

The Columbia County Sheriff's Office responded to a 911 report around noon, according to Undersheriff Jacqueline Salvatore, who said the crash was fatal but declined to reveal how many people died.

The Federal Aviation Administration said the Mitsubishi MU-2B was headed to Columbia County

Airport near Hudson, but crashed about 30 miles (48 kilometers) away near Copake.

"It's in the middle of a field and it's pretty muddy, so accessibility is difficult," Salvatore said during a news conference near the scene about 50 miles (80 kilometers) south of Albany.

The National Transportation Safety Board said it had deployed an investigation team, which was expected to arrive Saturday night.

Toronto rally calls for release of Mahrang Baloch

Toronto [Canada] : The Baloch Human Rights Council of Canada held a protest march in Toronto on April 12, demanding the immediate release of Mahrang Baloch and other leaders of the Baloch Yakjehti Committee (BYC), who are currently in detention.

Organisers said the protest marked the beginning of a wider solidarity campaign calling for their release from what they described as unlawful detention by the Pakistani government.

According to the council, the rally was organised in support of Baloch, currently held in Hudda Jail in Quetta, and other political workers. "We are here today for the release of Baloch political workers, especially our women, girls and daughters. They have been illegally abducted by the Pakistani government, by the Pakistani state," said a member of the council.

A member from the crowd said, "We are gathered here today to express our concern on the



arrest an imprisonment of human rights activist Dr Mahrang Baloch, who is a big voice in Balochistan against the enforced disappearances and atrocities committed by the state of Pakistan. She has been imprisoned when she was protesting outside the hospital where the bodies of many people had been brought. The families were concerned that they belonged to people who had been made to disappear by force, who were being

tortured and executed. (She) demanded these bodies be identified and the bodies be shown to the families for the same. The state instead arrested her."

He continued, "It is very important to us, the Canadian Baloch, Canadian government, international community, European Union, and the UN, that they should raise their voice and pressurise the Pakistani government and their institutions who are holding Mahrang in prison. We have

concerns that she was poisoned..."

The demonstration was hosted by the Baloch Human Rights Council of Canada and attended by members of various diaspora communities, including Iranian, Kurdish, Pashtun, and Sindhi rights groups. The President of Pashtun Council Canada, Bushra Khan, stated: "I am here to stand beside my Baloch friends to demand the release of Mahrang Baloch."

Protestors carried

banners and raised slogans calling for the Pakistani government to free Baloch and other BYC members. Speakers at the event claimed that Islamabad was attempting to link Baloch's peaceful civil rights campaign to terrorism-related charges.

They said Baloch's activism focused on civil liberties and women's rights and pointed to her recent nomination for the 2025 Nobel Peace Prize.

In a press release issued after the rally, the Baloch Human Rights Council alleged that the Pakistani state and its security

agencies were responsible for enforced disappearances, torture, extrajudicial killings, and widespread human rights violations in Balochistan. The council also raised concerns over what it described as increasing violence against Baloch women.

The protest follows weeks of international attention on the Baloch civil rights movement and comes amid growing criticism of Pakistan's security operations in the region. Organisers said further demonstrations may follow in other cities in the coming weeks.

Operation Brahma: Indian Army Engineers assess quake damage in Myanmar

Yangon [Myanmar], April 13 (ANI): In response to a formal request from the Government of Myanmar, a specialist team of Indian Army Engineers arrived in the country on 6 April 2025 under Operation Brahma, further reaffirming India's ongoing commitment to regional support and humanitarian relief.

According to the Indian Army, the Engineer Recce Team--led by the unit's Commanding Officer and comprising one officer and five personnel--has been deployed to assess earthquake-affected infrastructure in the Mandalay and Naypyitaw regions.

The deployment marks a crucial phase in India's continued efforts to support Myanmar following the deadly 7.7-magnitude earthquake that struck the nation on 28 March. The team has been conducting a comprehensive assessment of damaged structures and



facilities, providing critical technical input to guide ongoing relief and reconstruction measures.

Operation Brahma has been India's dedicated humanitarian outreach to Myanmar in the wake of the disaster. As part of this initiative, India has also extended aid to the Indian diaspora in the Yangon region.

The Embassy of India in Myanmar stated that Ambassador Abhay Thakur handed over 15 tonnes of rice, cooking oil, and foodstuff to a local community relief group. The Consulate General of India in Mandalay similarly contributed by providing a generator set, water purifier, and cooking oil to the Ambika temple kitchen,

which is currently serving meals to 4,000 people daily.

"Giving a helping hand to our diaspora. This week, Ambassador Abhay Thakur handed over 15 T rice, cooking oil & foodstuff to the community Relief Group in Yangon, and the Consulate General of India in Mandalay gave a genset, water purifier & cooking oil for Ambika temple kitchen

serving 4000 pax daily," the embassy said on X.

In Mandalay, India has also set up a Field Hospital to treat the injured. As of 9 April, the Indian Army reported that a total of 1,651 patients had been treated at the facility, including 281 on that day alone. Medical teams have performed seven major surgeries and 38 minor procedures. India

also delivered 442 tonnes of food aid last Friday, part of a cumulative 625 metric tonnes of humanitarian supplies sent under Operation Brahma.

The National Disaster Response Force (NDRF), comprising 80 personnel and four specially trained canine units, has also been deployed to support rescue operations on the ground.

According to Myanmar's State Administration Council, the earthquake has claimed 3,645 lives, injured 5,017 people, and left 148 missing. With damage spread across six regions--including the capital--and critical infrastructure disrupted, the situation remains dire.

The disaster has compounded an already severe humanitarian crisis from the ongoing civil war, which has displaced over three million people and left nearly 20 million in need of aid, according to UN figures cited by Al Jazeera.

Taiwan detects 6 Chinese vessels in its territory



Taipei [Taiwan] : Taiwan's Ministry of National Defence (MND) on Sunday reported the detection of six People's Liberation Army Navy (PLAN) vessels operating around the island as of 6 am (UTC+8).

In a post on X (formerly Twitter), the ministry said, "6 PLAN ships operating around

Taiwan were detected as of 6 am (UTC+8) today. Illustration of flight path is not provided due to no PLA aircraft operating around Taiwan were detected during this timeframe."

The latest development follows heightened activity recorded just a day earlier. On Saturday, the MND said it had detected 34

sorties of People's Liberation Army (PLA) aircraft and seven PLAN vessels operating around Taiwan by 6 a.m. that day.

Of the 34 aircraft, 19 crossed the Taiwan Strait's median line and entered Taiwan's southwestern and eastern Air Defence Identification Zones (ADIZ), underscoring increased Chinese military

presence in the region.

These frequent incursions and maritime operations reflect rising tensions between Taiwan and China, a relationship long fraught with geopolitical strain. Taiwan, officially the Republic of China (ROC), governs itself independently with its own political and economic systems.

However, China continues to claim Taiwan as part of its territory

under the "One China" principle, insisting there is only one China with its capital in Beijing.

The dispute's roots trace back to the end of the Chinese Civil War in 1949, when the ROC government fled to Taiwan after the Communist Party, led by Mao Zedong, took control of mainland China.

Since then, Beijing has maintained its goal of reunification, using military, diplomatic, and economic

means to apply pressure on Taiwan and diminish its international space.

Despite these efforts, Taiwan maintains its de facto independence with strong public support and continues to assert its sovereignty amid ongoing external pressures. The MND regularly monitors and publicly reports such military movements to ensure transparency and national security awareness.



26/11 attacks shocked entire world; America supports India's pursuit of justice: US



New York/Washington : The 26/11 terror attacks shocked the entire world and America has long supported India's efforts to ensure that those responsible are brought to justice, the US has said, as Pakistani-Canadian Tahawwur Hussain Rana was extradited to India to face justice for his involvement in the Mumbai carnage.

On April 9, the United States extradited Rana, 64, to India "to face justice for his role in planning the horrific 2008 Mumbai terrorist attacks," US Department of State Spokesperson Tammy Bruce said on Thursday.

"The United States has long supported India's efforts to ensure those responsible for these attacks are brought to justice, and as President Trump has said, the United States and India will continue to work together to combat the global scourge of terrorism," she said.

Rana is in India's "possession and we are very proud of that dynamic," she said.

Bruce added that some

people may not remember the attacks that resulted in the tragic loss of 166 lives, including six Americans, that shocked the entire world. "I encourage you to look them up and to find out exactly how horrible this was in the importance of this situation today," she said.

Earlier, a spokesperson for the US Department of Justice said in a statement that Rana's extradition is a "critical step toward seeking justice" for the victims of the heinous attacks.

The DOJ spokesperson said that the US extradited the convicted terrorist and Pakistani-Canadian citizen to stand trial in India on 10 criminal charges stemming from his alleged role in the 2008 terrorist attacks in Mumbai.

"Rana's extradition is a critical step toward seeking justice for the six Americans and scores of other victims who were killed in the heinous attacks," the spokesperson said.

A team led by the NIA authorities landed in India late Thursday with Rana who will now face justice in the country for his role and

involvement in the 26/11 Mumbai attacks carried out by Pakistan-based LeT terrorists.

The multi-agency team from India had gone to the US and all paperwork and legalities to bring Rana back to India were completed.

David Headley & his links with Tahawwur Rana

David Coleman Headley and Tahawwur Rana were friends when they were students at Hasan Abdal Cadet College, an elite military school in Pakistan. Later, Tahawwur Rana would provide "cover" for Headley's undercover terrorist reconnaissance activities.

Headley, born in Washington DC as Daood Gilani, is the son of Pakistani broadcaster Syed Saleem Gilani and American Serrill Headley. They moved to Pakistan when David was a baby. Soon, they divorced and Serrill returned to the US. The court proceedings against him in Chicago in 2013 indicated that Daood, alias David, grew up in an "environment of Pakistani nationalism and Islamic conservatism."

According to Headley's accounts, his hatred towards India started in 1971, when during the Indo-Pak war, a stray bomb hit his elementary school in Karachi, killing two persons.

At the age of 17, Headley returned to his mother in Philadelphia as he clashed with his Pakistani stepmother. His brush with the law started in 1988 due to drug addiction in the

US, Pakistan and Germany, where he was arrested. From then on, the US Drug Enforcement Agency (DEA) recruited him as an informer. In 1998, the DEA sent him to Pakistan as an undercover agent.

During that period, he developed links with Lashkar-e-Taiba. He said that he undertook trips to Pakistan without the permission of the US authorities. In 2000, he met Hafiz Saeed, the spiritual leader of Lashkar. In 2001, he again "signed up" with the DEA for another year of working. That gave him reasons for making frequent trips to the subcontinent.

Sebastian Rotella of 'Pro-Publica' and Prof Stephen Tankhel of the American University were primarily responsible for exposing to the world the secret links between 26/11 terrorist David Coleman Headley, his friend Tahawwur Hussain Rana and the ISI, which official US sources did not publicly indicate earlier.

In 2012, Stephen Tankhel figured along with me when the National Geographic interviewed us for their movie 'Seconds to Disaster: The Mumbai Massacre' on the 26/11 attack. In the same year, he came to Mumbai to launch his master treatise on Lashkar-e-Taiba ('Storming the World Stage') and its close links with Pakistan's ISI, which he gathered through field research in Pakistan and India in 2009. In 2017, he chaired the discussion of my book 'Keeping India Safe' at the National Press Club, Washington DC.

I came to know Sebastian Rotella personally only in June 2013, when he came to Mumbai to record my interview for a sequel of his 2011 documentary film 'A Perfect Terrorist' by the Public Broadcasting Service (PBS) about Headley's links with the Mumbai and Denmark plots. He was also investigating

why US agencies did not alert the Indian authorities about Headley's involvement and frequent trips to India, although a US diplomat had reported this to the FBI, DEA and CIA after interviewing his wife in Islamabad.

In January 2013, Judge Harry Leinenweber of the US Chicago District Court sentenced David Coleman Headley to a 35-year prison sentence for his deep involvement in the Mumbai massacre by way of prior reconnaissance for the attack. Included among the witnesses in Chicago was American author Linda Ragsdale, who was injured during 26/11 attack while two others at her dining table were killed. The court proceedings indicated that Headley, who had earlier confessed under a "plea bargain agreement", had watched the attack on TV from his home in Pakistan.

Headley told the court that he had attended Lashkar training camps in Pakistan five times between 2002 and 2005. In late 2005, he received instructions to travel to

India to conduct surveillance, which he did five times.

The court proceedings also indicated Leinenweber's disdain to the prosecution's request for not awarding Headley maximum punishment under the law for his involvement in the "horrific nature of the three-day slaughter in Mumbai." Although US Attorney Patrick Fitzgerald requested leniency in view of his "thorough" confession, the judge pointed out that Headley had received two "generous plea bargains" previously. when he was charged with heroin trafficking in the 1980s and 1990s. He said that he was awarding him the long sentence which "will keep him under lock and key for the rest of his natural life."

The proceedings against Tahawwur Rana in 2013 in the same court of Judge Harry Leinenweber of the US Chicago District Court gave proof of the close friendship between him and Headley, especially how Rana's "cover" of travel agency afforded the latter to make frequent trips to India and Pakistan.

Rana, who was described as an immigration consultant, "helped Headley conduct undercover terrorist reconnaissance by allowing him to work as an overseas representative of his immigration consulting firm. He also enabled Headley to open an office in Mumbai, use business cards, obtain visas and otherwise maintain a cover."

Judge Harry Leinenweber awarded Rana 14 years in prison for two counts of charges: for providing material support to Lashkar-e-Taiba's terrorism activities and for being involved in a plot to attack a Danish newspaper that published cartoons of Prophet Muhammad. He, however acquitted him of the charge of providing material support to Mumbai 26/11 attacks.

In this, he partially agreed with the jury's finding that they accepted Rana's argument that "he was not aware of the Mumbai plot and that his support of Lashkar did not play a role in that 2008 massacre." However, the judge found that Rana should have been aware of the "murderous potential" of such links after what happened in Mumbai in November 2008. He, therefore, increased the punishment to 14 years from 11 as mandated under the penal law. He also added five years of post-prison supervision to Rana's sentence.

True, Headley was examined online as a witness by a Mumbai court in February 2016 in the case of Abu Jundal. However, Rana's extradition to India affords us to interrogate him on his role in helping Headley in doing the prior reconnaissance.

This is because the Chicago jury's findings do not appear to have been based on the facts which our investigating agencies had provided to their counterparts in the USA. That is why Rana's extradition is important.

Trump disruption is a one-way street with no road map

Donald Trump has blinked. His 90 days' reprieve was triggered by events on the bond market, according to analysts. But then, these were predictable events. It remains to be seen how sustainable would be the strategy with regard to China. President Xi Jinping is not one for blinking. After having yielded ground to rest of the world, President Trump needs to find a way to re-engage China, even if on altered terms.

Disruption is a one-way street, with no roadmap. To suggest that Trump and his advisers are working on a plan is at best a statement of hope, at worst a downright lie.

The medium-term impact of the Trump disruption is to increase uncertainty. Economic activity is based on expectations. Uncertainty alters expectations, making firms and households cautious.

The 90-day reprieve that Trump has announced only extends the period of uncertainty; it does not in any way end that

uncertainty. Caution replaces animal spirits. Expect a global slowdown, irrespective of what corrective measures countries may take.

There are two objectives that Trump hopes to achieve through his disruptive tariff policy. First, the restoration of American manufacturing, with lost blue-collar jobs being reclaimed.

Second, punishing China for taking undue advantage of the global trading system that it was let into by the United States a quarter century ago. For Trump's domestic political support base, the former is more important, the latter is a secondary objective.

Of what use is hurting China if at home more jobs are not being created and only prices are going up? The problem is that Trump will find achieving the first goal, of reviving the home economy, more difficult than scoring some goals on the second front, of hurting China. China is, of course, prepared for Trump.

Since all the strategies for the so-called 'geo-economic containment' of China have been written about in books and papers published over the past two decades in the US, the Chinese have a good idea as to what they should expect and be prepared for.

Is the US prepared for the fallout? After all, reviving manufacturing is not like hosting a potluck party. There are time lags involved. If Trump's unemployed supporters have to wait for a couple of years for jobs, will they not become restive? Pain in short term, gain in long term is not politically sustainable.

If domestic support for Trump slumps, what should one expect in terms of his external policy response? More disruption?

The focus of much global commentary over the past week has largely been on trade and tariffs and it is economists who

have been at the forefront of much media commentary.

As the dust settles, geopolitical analysts will step in to understand what the long-term consequences of the Trump disruption would be for international relations. One major consequence is likely to be a loss of global trust in the US.

Even if Trump rolls back all his actions and eats all his words — like claiming that world leaders were lining up to 'kiss his arse' — few heads of government around the world would any longer trust the Trump administration. Consider the countries that Trump has openly targeted and visibly alienated — Canada, Mexico, Denmark, South Africa. Then there are countries whose leaders have been willing to be publicly critical of Trump — Brazil,

Colombia, Germany, France, Singapore, Namibia, Australia and so on.

This, however, does not reveal the full extent of global dismay and disapproval of Trump. The European Union is divided, but a majority will no longer trust the US.

The President of the European Commission, Ursula von der Leyen, has welcomed Trump's retreat and called for greater internal market integration within the EU. The EU will maintain trade relations with China and reach out to India and others.

Japan has publicly behaved like a supplicant, led as it is by a politically weak prime minister, but it may well have queered the pitch for the 90-day retreat by selling on the US bond market. Japan will try to stabilise trade relations with China.

The Indian political leadership has tread warily. It is delighted that the focus of Trump's attack is on China. It is hoping to strike a deal with Trump by offering to buy more, including more defence equipment. Even so, would Prime Minister Narendra Modi feel as comfortable today in dealing with Trump as he did during Trump's first term? After all, Trump has directly snubbed him and repeatedly referred to India in not very friendly terms.

While large sections of the Indian elite, the media and the political class have not made a big deal of Trump's badmouthing of India, and some have even tried to explain it away, a political leader like Modi, with his ego and his self-image, must surely have resented in private the many slights that came his way.

The US and India have many shared interests and India would like to sustain and stabilise its strategic partnership with the US. However, no Indian leader would like to be seen supplicating before a Trump in the manner that Japan's Shigeru Ishiba has done or Italy's Georgia Meloni is willing to.

Prime Minister Modi's silence so far, perhaps awaiting further indications on the progress of a bilateral trade agreement, has left the field open to others to be the 'voice of the Global South'.

Beijing has been forthright in speaking on behalf of the Global South, expressing solidarity with developing economies against the disruption of global trade, and inviting India to get on board, conveying the concerns of developing economies.

The leaders of both Brazil and South Africa have expressed their solidarity with other developing countries. The Global South awaits India's Voice.

The US is clear. It will take action against illegal immigration

to encourage your loved ones to come home. Trying to enter or remain illegally will no longer succeed. Some people believe they can enter the United States illegally and avoid being caught. This is not true.

The Trump administration has strengthened border security and greatly increased the number of illegal aliens being arrested and deported.

In February 2025, illegal border crossings dropped 94 per cent compared to February 2024, while arrests of illegal border crossers inside the United States increased by 627 per cent.

Those who try to cross a US border or remain in the United States illegally will be caught, detained and sent back. They may also be banned from ever returning or face fines and criminal charges.

The US visa process is the most secure in the world. Yet, some people unwisely try to abuse the system by using fake documents, falsifying applications or staying after their visa expires, often with the help of facilitators who prey on migrants to make money. These are examples of visa fraud, which is a serious crime.

Those who break the law in this way will be punished and may never be allowed to enter the United States again.

For those considering making the dangerous journey to illegally cross into the United States, understand that your safety — and even your life — are at risk. Criminal groups, cartels and human traffickers target illegal migrants, subjecting them to violence, extortion and assault. Many who attempt the journey never make it to their destination.

Others mortgage property or take out loans to pay enormous sums to traffickers, only to lose it all when they are deported back to their country of origin.
